

THE TOURIST COMPANY OF NIGERIA PLC
UNAUDITED RESULTS FOR THE SIX MONTHS ENDED 31 DECEMBER 2016

The Company's revenue decreased by 5% to last year, with a declines in gaming and hospitality revenue of 4% and 6% respectively. Controlled direct costs increased 11%. Foreign exchange losses of N1,258m were incurred on shareholder loans which resulted in a loss before tax of N1,918m for the period under review, compared to a loss of N307m for the previous period.
